

Caseville Township Board Meeting October 3, 2022

Meeting called to order at 4:00 p.m. by Ben Willenberg.

Present: Ben Willenberg, Michelle Stirrett, Chelsey Klawon, Jerry Platko. Absent: Laurie Marrocco.

Seven citizens were present.

Motion by Stirrett second by Platko to approve the agenda, the September 6, 2022 Board minutes, Treasurer's report and bills. **Motion carried.**

Fire Association Budget

Motion by Platko second by Stirrett to approve the amendment to the Fire Association's budget to include the purchase of an air compressor at a cost of \$60,000. **Motion carried.**

Budget adjustments

Motion by Willenberg second by Stirrett to amend the budget for contract labor and Twp. Site clean up (101265715) in the amount of \$20,000 to include mower purchase and electricity. **Motion carried.**

Motion by Stirrett second by Klawon to amend the Election budget in the amount of \$3,000 for election expenses for the General election. **Motion carried.**

Recreation Committee

The Capital Improvement Committee submitted a budget recommendation for the use of the ARPA funds in the amount of \$107,220. The budget included engineering costs, property enhancements, parking, walking path and pavilion. **Motion** by Stirrett second by Willenberg to approve the Parks and Recreation budget using ARPA funds for recreation projects. **Motion carried.**
